Regulatory framework

What is e-cohesion?

Regulatory framework for e-cohesion Article 122.3 Responsibilities of Member States on Management and Control systems (CPR 1303/2013)

Member States shall ensure that no later than 31 December 2015 all exchanges of information between beneficiaries and managing authorities, certifying authorities, audit authorities and intermediate bodies can be carried out by means of electronic data exchange systems.

The systems shall facilitate interoperability with national and Union frameworks and allow for the beneficiaries to submit all information referred to in the first sub-paragraph only once. The Commission shall adopt, by means of implementing acts, detailed rules concerning the exchanges of information (...)

Minimum requirements on e-Cohesion

- Electronic exchange;
- 'Only once' encoding + interoperability;
- data integrity + confidentiality,
- authentication of the sender (Directive 1999/93/EC),
- storage in compliance with defined retention rules (Article 140 of the CPR).
- Electronic audit trail -in compliance with Art. 122, 140 + national requirements on the availability of documents.


