The 2<sup>nd</sup> Interreg VI-A Italy-Slovenia Monitoring Committee (MC) meeting takes place online on Zoom platform on December 19<sup>th</sup>, 2022 (10.00 a.m. to 13.00 p.m.).

The SPF Action Plan and its financial plan will be concluded within the WP5. The Italian Delegation proposed the additional member from Veneto Region into ad hoc Committee, taking into account the fact of avoiding the double financing, and the provisions of article 25 of Interreg Regulation. The Slovene Delegation takes the position that the Selection Committee remains as it is proposed in the SPF Action Plan (the item of 5<sup>th</sup> WP) meaning it consists of



three members (one from FVG Region, one from Javni zavod GO!2025 and one from EGCT GO).

Slovenia will formalise its new composition of MC's membership, following reorganisation of Slovene Government, probably in January/ February

The establishment of MC's devoted Working Groups (evaluation, risk assessment, communication) will follow.
