

#### Main objective

Strengthen the institutional capacity of the ports of Italy and Slovenia as to create the basis for a coordinated and permanent governance of port security at a cross-border level, strengthening security and competitiveness. **Results:**

- 2) Harmonization of policies and actions to strengthen port security across borders
- 3) Institutionalization of a cross-border governance of port security







## **SECNET - planning**


Improvement of port skills in joint planning of port security and in the use of ICT tools:
